9. Best Evaluated Bid:

The lowest substantially responsive and in all aspects complying bid is the Bidder 05: Odjove Trading and Construction CC with a corrected bid price of N\$ 8,181,072.57 including value added tax (VAT).

Odjove Trading and Construction CC demonstrated to possess sufficient technical experience, personnel capacity, equipment and financial resources to undertake this project. The bidder has vast and adequate experience in projects of similar nature and the Bid Evaluation Committee is confident that if given the opportunity, they will successfully complete the project.

Their documentation is complete and the price calculation was corrected and subsequently accepted by the bidder, therefore, no clarification / negotiation is required other than the completion of all relevant details in the contract agreement form, the compilation of all required annexures to the contract as well as the provision of the performance security and copies of the required insurances.

It is recommended that the Contract for the Construction of Access Roads to Schools and Clinics of DR 3562: Makanga access road (3.54KM) and DR 3525: Masida access road (3.04KM) (6.58KM), with Procurement Reference No. **W/ONB/RA-35/2023**, be awarded to Odjove Trading and Construction CC at the corrected bid price of **N\$ 8,181,072.57** including VAT, for a construction period of **six (06) Months**.
